I didn't know how to go about getting an attorney because I had discovered when notified that I was eligible for student loan reimbursement a couple years prior, but was refused the same, that LEE COUNTY, FLORIDA was the ONLY county in Florida with a private attorney referral service?

The corruption in LEE COUNTY, Florida blocked me from anything and everything I attempted as a human being for 30 + years.

The attorney that I had to get to fight for the student loan reimbursement, a couple years earlier before the patent, took half, \$5000.00.
